- 3.3.8 Performance for use in exterior walls of buildings as continuous insulation (ci) in accordance with <u>IECC</u> <u>Section C402.1.3</u>
- 3.3.9 Performance in exterior walls of buildings as vapor retarding FPIS in accordance with IBC Section 1404.3<sup>10</sup>

### 4 **Product Description and Materials**




Figure 1. R2+ SHEATHE

- 4.1 This innovative product, R2+ SHEATHE, pictured in Figure 1, is a proprietary FPIS product.
  - 4.1.1 R2+ SHEATHE is a composite board consisting of a 25 psi closed cell polyisocyanurate foam core, coated on both sides with a glass-backed aluminum foil facer (ASTM C1289 Type I, Class 1).

#### 4.2 Material Availability

#### Applications 5

- 5.1 General
  - 5.1.1 R2+ SHEATHE is a FPIS product complying with IBC Section 2603.
  - 5.1.2 R2+ SHEATHE is used in exterior walls of buildings of any height and of Type I-IV construction in accordance with IBC Section 2603.5.
  - 5.1.3 Environmental Product Declarations (EPD) for R2+ SHEATHE are available at polyiso.org.

#### 5.2 Vapor-Retarding Insulated Sheathing

5.2.1 R2+ SHEATHE has a permeance rating of <1. Per IBC Section 1404.3.2, <sup>12</sup> only Class III vapor retarders shall be used on the interior side of walls framed with insulated sheathing with <1 perm installed on the exterior side of the framed wall. Water vapor permeance of R2+ SHEATHE is presented in Table 1.

#### Air Barrier 5.3

R2+ SHEATHE meets the requirements of <u>IECC Section C402.5.1</u> for use as an air barrier material and an 5.3.1 air barrier assembly when installed in accordance with the manufacturer installation instructions and this TER, with all seams including the top and bottom edges taped. See Table 2.

#### 5.4 Water-Resistive Barrier (WRB)

- 5.4.1 R2+ SHEATHE may be used as a WRB as prescribed in <u>IBC Section 1403.2</u><sup>13</sup> and <u>IRC Section R703.2</u>,<sup>14</sup> when installed on exterior walls as described in this section.
- 5.4.2 R2+ SHEATHE shall be installed horizontally or vertically with board joints placed directly over exterior framing spaced a maximum of 24" (610 mm) o.c. The fasteners used to attach the board shall be installed in accordance with Section 6.
- 5.4.3 All seams and joints between boards shall be covered by 4" wide Carlisle® Coatings & Waterproofing Foil Grip™ 1402 pressure sensitive foil-faced flashing tape.
- 5.4.4 A separate WRB may also be provided. If a separate WRB method is used, taping of the sheathing joints is not required.
- 5.4.5 Flashing of penetrations is required and shall comply with the applicable code.

#### 5.5 Fire Safety Performance

- 5.5.1 Surface Burn Characteristics:
  - 5.5.1.1 R2+ SHEATHE was evaluated to assess performance with regard to the flame spread and smoke developed index in accordance with ASTM E84 as shown in Table 3.

#### 5.5.3 Potential Heat:

5.5.3.1 R2+ SHEATHE was tested in accordance with NFPA 259 to assess the potential heat generated by the FPIS in accordance with <u>IBC Section 2603.5.3</u>, as shown in Table 4.

#### 5.5.4 Vertical and Lateral Fire Propagation:

- 5.5.4.1 R2+ SHEATHE was tested to assess its performance with regard to vertical and lateral fire propagation in accordance with NFPA 285 and <u>2018 IBC Section 2603.5.5</u>.
- 5.5.4.2 Engineering analysis has also been conducted to assess substitution of other products within the approved wall assemblies.
- 5.5.4.3 The wall assemblies listed in Table 5 and Table 6 are approved for use in building of Type I-IV construction.

- 5. In the NFPA 285 test, flashing for fenestration, including Through-Wall Flashing (TWF), are not considered part of the WRB (ref: <u>2015 IBC Section 1405.4</u>). TWF is permitted for use in wall assemblies clad with masonry or stone at the base of wall, head of wall, relieving angle, window head, window sill, and at other interruptions in the exterior cavity.   - b. Pre-Kleened EPDM TWF loose-laid or adhered with SURE-SEAL 90-8-30A bonding Adhesive or SURE-SEAL Low VOC Bonding Adhesive c. Metal TWF by others
- 6. BRT-801 tape may be used over Fire-Resist 705 RS at membrane splices, terminations, and penetrations. Fire-Resist 705 RS and the substrate may be treated with CCW-702, CCW-702 LV, CCW-702 WB, or Low VOC Travel-Tack to promote adhesion of BRT-801.
- 7. Fire-Resist 705 RS may be used in the following applications:

5.6 Where the application falls outside of the performance evaluation, conditions of use and/or installation requirements set forth herein, alternative techniques shall be permitted in accordance with accepted engineering practice and experience. This includes but is not limited to the following areas of engineering: mechanics or materials, structural, building science, and fire science.

#### 6 Installation

- 6.1 Installation shall comply with the approved construction documents, the manufacturer installation instructions, this TER and the applicable building code.
- 6.2 In the event of a conflict between the manufacturer installation instructions and this TER, the more restrictive shall govern.
- 6.3 Installation Procedure
  - 6.3.1 This section provides general guidelines for the installation of R2+ SHEATHE only. Refer to the manufacturer installation instructions in addition to this TER, for complete details and requirements.
    - 6.3.1.1 Protect surrounding areas and surfaces from damage.
    - 6.3.1.2 For installation of R2+ SHEATHE on exterior, over WRB on base wall: Ensure that WRB is installed correctly and is in good condition before covering with R2+ SHEATHE.
    - 6.3.1.2.1 When used in a NFPA 285 approved assembly, WRB must be one of those identified in Table 5.
    - 6.3.1.3 For installation of R2+ SHEATHE on interior, over air/water resistive barrier on base wall: Ensure that air/water resistive barrier is one of those identified in Table 6 and air/water resistive barrier is installed correctly and is in good condition before covering with R2+ SHEATHE.
      - 6.3.1.3.1 When used in a NFPA 285 approved assembly, the air/water resistive barrier must be one of those identified in Table 6.
    - 6.3.1.4 R2+ SHEATHE shall not be applied over walls while they are vulnerable to water intrusion from above or behind.
    - 6.3.1.5 Do not block flashing, weeps or other drainage paths with R2+ SHEATHE.
    - 6.3.1.6 Do not span expansion joints with R2+ SHEATHE.
    - 6.3.1.7 During installation, take precautions to minimize moisture intrusion behind insulation.
    - 6.3.1.8 Beginning at the base of the wall, apply horizontally using maximum board lengths to minimize the number of joints.
    - 6.3.1.9 Offset R2+ SHEATHE board joints in neighboring rows a minimum of 6". Do not form four-corner intersections.
    - 6.3.1.10 R2+ SHEATHE may be applied vertically, as required.
    - 6.3.1.11 Pre-cut to fit openings and penetrations.
    - 6.3.1.12 Cut with a knife, using a square to guide the cut, or use a table saw.
    - 6.3.1.13 Abut all joints tightly and ensure an overall flush, level surface.
    - 6.3.1.14 Mechanically fasten using the fastening pattern as indicated.
    - 6.3.1.14.1 Space fasteners 12" o.c. at the perimeter and 16" o.c. in the field.
    - 6.3.1.14.2 Set back perimeter fasteners 3/8" from board edges.





- 6.3.1.14.3 **Note for exterior application**: Where R2+ SHEATHE is installed by the same trade as the cladding, or in close cooperation with that trade, cladding attachment hardware can supplement or replace the insulation fasteners and insulation adhesive. Cladding fasteners fulfilling the R2+ SHEATHE attachment function shall be designed for this function. If the cladding attachment is 16" o.c. or closer, and it tightly secures the insulation, no additional fastening or adhesive is required.
- 6.3.1.14.4 **Note for interior application**: Where R2+ SHEATHE is installed by the same trade as the interior drywall, or in close cooperation with that trade, drywall attachment hardware can supplement or replace the insulation fasteners and insulation adhesive. Drywall fasteners fulfilling the R2+ SHEATHE attachment function shall be designed for this function. If the drywall attachment is 16" o.c. or closer, and it tightly secures the insulation, no additional fastening or adhesive is required.
- 6.3.1.15 When an approved adhesive is used, periodically verify adhesion. Properly installed adhesively applied R2+ SHEATHE will cohesively break the adhesive while still wet and destroy the substrate when dry.
  - 6.3.1.15.1 Consult the detailed manufacturer installation instructions for the proper adhesive pattern to maintain the drainage plane.
  - 6.3.1.15.2 When used in a NFPA 285 approved assembly, adhesives must be one of those listed in Table 5, Table 6 or Table 7.
- 6.3.1.16 Fill gaps greater than <sup>1</sup>/<sub>8</sub>" between insulation boards with expanding spray foam with approved sealant and strike flush. Expanding spray foam may also be applied onto the insulation board edges during installation.
- 6.3.1.17 Verify all materials are installed in accordance with current Carlisle® Coatings & Waterproofing (CCW) published literature and local code requirements.
- 6.3.1.18 Additional information on the installation and detailing of R2+ SHEATHE can be found at <u>carlisleccw.com</u>.
- 6.3.2 This section provides additional guidelines for the installation of R2+ SHEATHE as an air and water-resistive barrier:
  - 6.3.2.1 When used in a NFPA 285 approved assembly as an air/water resistive barrier, see also Section 5.4 and Table 6.
  - 6.3.2.2 When used in a NFPA 285 approved assembly as a WRB, see also Section 5.5 and Table 7 with all notes.
  - 6.3.2.3 Use minimum 1" thickness R2+ SHEATHE.
  - 6.3.2.4 Install directly over wood or steel studs or over exterior sheathing fastened to wood or steel studs.
  - 6.3.2.5 Fasten R2+ SHEATHE boards with corrosion-resistant screws or Heckmann Pos-I-Tie® fitted with Thermal-Grip® ci plastic washers by Rodenhouse. Space fasteners 16" o.c. in the field and 12" o.c. at the perimeter.
    - 6.3.2.5.1 Other fastening used shall be installed 16" o.c. in the field and 12" o.c. at the perimeter. Other fastening shall be verified as air and water tight through ASTM E2357 and ASTM E331 testing, or it shall be sealed with caulk or flashing tape.
  - 6.3.2.6 Tape over board joints with 4" width Aluma-Grip™ 1402 tape by CCW.
  - 6.3.2.7 Cover inside/outside corners with Aluma-Grip<sup>™</sup> 701 by CCW. Aluma-Grip<sup>™</sup> 701 shall bear 3" minimum onto each side of angle.
  - 6.3.2.8 Wrap window openings with Aluma-Grip<sup>™</sup> 701. Aluma-Grip<sup>™</sup> 701 shall wrap at least 3" onto wall, and shall return far enough into the window opening to provide continuous air/water seal to window frame.
  - 6.3.2.9 Flash pipe and duct penetrations through R2+ SHEATHE with Aluma-Grip<sup>™</sup> 701.
  - 6.3.2.10 Consult CCW details and instructions for complete information about installation of R2+ SHEATHE as an air and water-resistive barrier.

- 7.1 Testing has been performed under the supervision of a professional engineer and/or under the requirements of ISO/IEC 17025 as follows:
  - 7.1.1 Flame spread and smoke developed ratings testing in accordance with UL 723
  - 7.1.2 Fire performance criteria testing in accordance with NFPA 285
  - 7.1.3 Fire performance criteria testing in accordance with NFPA 286
  - 7.1.4 Potential heat testing in accordance with NFPA 259
  - 7.1.5 Air barrier material testing in accordance with ASTM E2178
  - 7.1.6 Air barrier assembly testing in accordance with ASTM E2357
  - 7.1.7 Vapor impermeability testing in accordance with ASTM E96 Method A and Method B
  - 7.1.8 Water-resistive barrier testing in accordance with ASTM E331
- 7.2 Engineering analysis comparing the fire resistance properties of R2+ SHEATHE by Priest and Associates
- 7.3 Engineering analysis assessing the substitution of products within the approved NFPA 285 tested wall assemblies by Priest and Associates
- 7.4 Information contained herein may include the result of testing and/or data analysis by sources that are <u>approved agencies</u> (i.e., ANAB accredited agencies), <u>approved sources</u> (i.e., RDPs), and/or <u>professional</u> <u>engineering regulations</u>. Accuracy of external test data and resulting analysis is relied upon.
- 7.5 Where pertinent, testing and/or engineering analysis is based upon provisions that have been codified into law through state or local adoption of codes and standards. The developers of these codes and standards are responsible for the reliability of published content. DrJ's engineering practice may use a code-adopted provision as the control sample. A control sample versus a test sample establishes a product as <u>being equivalent</u> to the code-adopted provision in terms of quality, <u>strength</u>, effectiveness, <u>fire resistance</u>, durability, and safety.
- 7.6 The accuracy of the provisions provided herein may be reliant upon the published properties of raw materials, which are defined by the grade mark, grade stamp, mill certificate, <u>Listings</u>, <u>certified reports</u>, <u>duly authenticated reports</u> from <u>approved agencies</u>, and <u>research reports</u> prepared by <u>approved agencies</u> and/or <u>approved sources</u> provided by the suppliers of products, materials, designs, assemblies and/or methods of construction. These are presumed to be minimum properties and relied upon to be accurate. The reliability of DrJ's engineering practice, as contained in this TER, may be dependent upon published design properties by others.
- 7.7 Testing and engineering analysis: The strength, rigidity and/or general performance of component parts and/or the integrated structure are determined by suitable tests that simulate the actual conditions of application that occur and/or by accepted engineering practice and experience.<sup>18</sup>
- 7.8 Where additional condition of use and/or code compliance information is required, please search for R2+ SHEATHE on the <u>DrJ Certification</u> website.

### 8 Findings

- 8.1 As delineated in Section 3, R2+ SHEATHE has performance characteristics that were tested and/or meet pertinent standards and is suitable for use pursuant to its specified purpose.
- 8.2 When used and installed in accordance with this TER and the manufacturer installation instructions, R2+ SHEATHE shall be approved for the following applications:
  - 8.2.1 Use in exterior walls of buildings of any height of Type I-IV construction in accordance with <u>IBC Section</u> <u>2603.5</u>
  - 8.2.2 Use in wall assemblies meeting the requirements of NFPA 285 testing when constructed in accordance with Table 5
  - 8.2.3 Complies with, or is a suitable alternative to, the applicable sections of the codes listed in Section 2
  - 8.2.4 Use in exterior walls of buildings as a WRB in accordance with <u>IBC Section 1403.2</u><sup>19</sup>
  - 8.2.5 Use in exterior walls of buildings as an air barrier in accordance with <u>IECC Section C402.5.1</u>
- 8.3 Unless exempt by state statute, when R2+ SHEATHE is to be used as a structural and/or building envelope component in the design of a specific building, the design shall be performed by an RDP.
- 8.4 Any application specific issues not addressed herein can be engineered by an RDP. Assistance with engineering is available from Carlisle® Coatings & Waterproofing Inc (CCW).
- 8.5 <u>IBC Section 104.11 (IRC Section R104.11</u> and <u>IFC Section 104.10</u><sup>20</sup> are similar) in pertinent part states:

**104.11** Alternative materials, design and methods of construction and equipment. The provisions of this code are not intended to prevent the installation of any material or to prohibit any design or method of construction not specifically prescribed by this code. Where the alternative material, design or method of construction is not approved, the building official shall respond in writing, stating the reasons the alternative was not approved.

- 8.6 **Approved**:<sup>21</sup> Building codes require that the <u>building official</u> shall accept <u>duly authenticated reports</u><sup>22</sup> or <u>research reports</u><sup>23</sup> from <u>approved agencies</u> and/or <u>approved sources</u> (i.e., licensed RDP) with respect to the quality and manner of use of new products, materials, designs, services, assemblies, or methods of construction.
  - 8.6.1 <u>Acceptance</u> of an <u>approved agency</u>, by a building official, is performed by verifying that the agency is accredited by a recognized accreditation body of the <u>International Accreditation Forum</u> (IAF).
  - 8.6.2 <u>Acceptance</u> of a licensed RDP, by a building official, is performed by verifying that the RDP and/or their business entity is listed by the <u>licensing board</u> of the relevant <u>jurisdiction</u>.
  - 8.6.3 Federal law, <u>Title 18 US Code Section 242</u>, requires that where the alternative product, material, service, design, assembly, and/or method of construction is not approved, the building official shall respond in writing, stating the reasons why the alternative was not approved, as denial without written reason deprives a protected right to free and fair competition in the marketplace.

- 8.7 DrJ is an engineering company, employs RDPs and is an ISO/IEC 17065 <u>ANAB-Accredited Product</u> <u>Certification Body</u> – <u>Accreditation #1131</u>.
- 8.8 Through ANAB accreditation and the <u>IAF Multilateral Agreements</u>, this TER can be used to obtain product approval in any jurisdiction or country that has <u>IAF MLA Members & Signatories</u> to meet the <u>Purpose of the</u> <u>MLA</u> "certified once, accepted everywhere." IAF specifically says, "Once an accreditation body is a signatory of the IAF MLA, it is required to recognise certificates and validation and verification statements issued by conformity assessment bodies accredited by all other signatories of the IAF MLA, with the appropriate scope."<sup>24</sup>

### 9 Conditions of Use

- 9.1 Material properties shall not fall outside the boundaries defined in Section 3.
- 9.2 As defined in Section 3, where material and/or engineering mechanics properties are created for load resisting design purposes, the resistance to the applied load shall not exceed the ability of the defined properties to resist those loads using the principles of accepted engineering practice.
- 9.3 As listed herein, R2+ SHEATHE shall not be used:
  - 9.3.1 As a structural nailing base for claddings.
  - 9.3.2 To resist lateral loads. Walls shall be braced by other materials in accordance with the applicable code, and the exterior wall covering shall be capable of resisting the full design wind pressure.
- 9.4 This TER and the installation instructions, when required by a code official, shall be submitted at the time of permit application.
- 9.5 When the insulation boards are used on the exterior side of exterior walls of buildings of Type I, II, III, or IV construction must be as described in Table 5.
- 9.6 When the insulation boards are used on the interior side of exterior walls of buildings of Type I, II, III, or IV construction must be as described in Table 6.
- 9.7 When installed in areas where the probability of termite infestation is "very heavy" the installation must meet the requirements of <u>IBC Section 2603.8</u>.
- 9.8 R2+ SHEATHE is manufactured in Smithfield, Pennsylvania; Franklin Park, Illinois; or Puyallup, Washington under a quality control program with quality control inspections in accordance with <u>IBC Section 110.3.10</u><sup>25</sup> and <u>IBC Section 110.3.11</u>.<sup>26</sup>
- 9.9 The wall assemblies listed in Table 5, Table 6, and Table 7 are based on compliance to the fire provisions of the codes listed in Section 2. Consideration of wall assembly performance with regard to other attributes, such as water vapor control, condensation, energy code requirements, etc. are outside the scope of this TER.
- 9.10 When required by adopted legislation and enforced by the <u>building official</u>, also known as the authority having jurisdiction (AHJ) in which the project is to be constructed:
  - 9.10.1 Any calculations incorporated into the construction documents shall conform to accepted engineering practice, and, when prepared by an <u>approved source</u>, shall be approved when signed and sealed.
  - 9.10.2 This TER and the installation instructions shall be submitted at the time of permit application.
  - 9.10.3 This innovative product has an internal quality control program and a third-party quality assurance program.
  - 9.10.4 At a minimum, this innovative product shall be installed per Section 6 of this TER.
  - 9.10.5 The review of this TER, by the AHJ, shall be in compliance with IBC Section 104 and IBC Section 105.4.

- 9.10.6 This innovative product has an internal quality control program and a third party quality assurance program in accordance with <u>IBC Section 104.4</u>, <u>IBC Section 110.4</u>, <u>IBC Section 1703</u>, <u>IRC Section R104.4</u> and <u>IRC Section R109.2</u>.
- 9.10.7 The application of this innovative product in the context of this TER is dependent upon the accuracy of the construction documents, implementation of installation instructions, inspection as required by <u>IBC Section</u> <u>110.3</u>, <u>IRC Section R109.2</u> and any other regulatory requirements that may apply.
- 9.11 The approval of this TER by the AHJ shall comply with <u>IBC Section 1707.1</u>, where legislation states in pertinent part, "the <u>building official</u> shall accept duly authenticated reports from <u>approved agencies</u> in respect to the quality and manner of <u>use</u> of new materials or assemblies as provided for in <u>Section 104.11</u>", all of <u>IBC Section 105.4</u>.
- 9.12 <u>Design loads</u> shall be determined in accordance with the building code adopted by the jurisdiction in which the project is to be constructed and/or by the building designer (i.e., <u>owner</u> or RDP).
- 9.13 The actual design, suitability, and use of this TER, for any particular building, is the responsibility of the <u>owner</u> or the owner's authorized agent.

#### 10 Identification

- 10.1 The innovative product listed in Section 1.1 is identified by a label on the board or packaging material bearing the manufacturer name, product name, TER number, and other information to confirm code compliance.

  - 1.1.1 Advance Innovation,
  - 1.1.2 Promote competition so all businesses have the opportunity to compete on price and quality in an open market on a level playing field unhampered by anticompetitive constraints, and
  - 1.1.3 Benefit consumers through lower prices, better quality, and greater choice.
- 1.2 **Adopted Legislation**: The following local, state, and federal regulations affirmatively authorize R2+ SHEATHE to be approved by AHJs, delegates of building departments, and/or <u>delegates of an agency of the federal government</u>:
  - 1.2.1 Interstate commerce is governed by the <u>Federal Department of Justice</u> to encourage the use of innovative products, materials, designs, services, assemblies and/or methods of construction. The goal is to "protect economic freedom and opportunity by promoting free and fair competition in the marketplace."
  - 1.2.2 <u>Title 18 US Code Section 242</u> affirms and regulates the right of individuals and businesses to freely and fairly have new products, materials, designs, services, assemblies and/or methods of construction approved for use in commerce. Disapproval of alternatives shall be based upon non-conformance with respect to specific provisions of adopted legislation, and shall be provided in writing <u>stating the reasons</u> why the alternative was not approved, with reference to the specific legislation violated.
  - 1.2.3 The <u>federal government</u> and each state have a <u>public records act</u>. In addition, each state also has legislation that mimics the federal <u>Defend Trade Secrets Act 2016</u> (DTSA),<sup>27</sup> where providing test reports, engineering analysis and/or other related IP/TS is subject to <u>prison of not more than 10 years</u><sup>28</sup> and/or <u>a</u> <u>\$5,000,000 fine or 3 times the value of</u><sup>29</sup> the Intellectual Property (IP) and Trade Secrets (TS).
    - 1.2.3.1 Compliance with public records and trade secret legislation requires approval through the use of listings, certified reports, Technical Evaluation Reports, duly authenticated reports and/or research reports prepared by approved agencies and/or approved sources.
  - 1.2.4 For <u>new materials</u><sup>30</sup> that are not specifically provided for in any building code, the <u>design strengths and</u> <u>permissible stresses</u> shall be established by <u>tests</u>, where <u>suitable load tests simulate the actual loads and</u> <u>conditions of application that occur</u>.
  - 1.2.5 The <u>design strengths and permissible stresses</u> of any structural material shall <u>conform</u> to the specifications and methods of design using accepted engineering practice.<sup>31</sup>
  - 1.2.6 The commerce of <u>approved sources</u> (i.e., registered PEs) is regulated by <u>professional engineering</u> <u>legislation</u>. Professional engineering <u>commerce shall always be approved</u> by AHJs, except where there is evidence, provided in writing, that specific legislation has been violated by an individual registered PE.
  - 1.2.7 The AHJ <u>shall accept duly authenticated reports</u> from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in <u>IBC Section 104.11</u>.<sup>32</sup>

- 1.3 Approved<sup>33</sup> by Los Angeles: The Los Angeles Municipal Code (LAMC) states in pertinent part that the provisions of LAMC are not intended to prevent the use of any material, device, or method of construction not specifically prescribed by LAMC. The Department shall use Part III, Recognized Standards in addition to Part II, Uniform Building Code Standards of <u>Division 35</u>, <u>Article 1</u>, <u>Chapter IX</u> of the LAMC in evaluation of products for approval where such standard exists for the product or the material and may use other approved standards, which apply. Whenever tests or certificates of any material or fabricated assembly are required by <u>Chapter IX</u> of the LAMC, such tests or certification shall be made by a <u>testing agency</u> approved by the Superintendent of Building to conduct such tests or provide such certifications. The testing agency shall publish the scope and limitation(s) of the listed material or fabricated assembly.<sup>34</sup> The Superintendent of Building <u>roster of approved testing agencies</u> is provided by the Los Angeles Department of Building and Safety (LADBS). The Center for Building Innovation (CBI) <u>Certificate of Approval License is TA24945</u>. Tests and certifications found in a <u>CBI Listing</u> are LAMC approved. In addition, the Superintendent of Building <u>shall accept duly authenticated reports</u> from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in the California Building Code (<u>CBC</u>) <u>Section 1707.1</u>.<sup>35</sup>
- 1.4 Approved by Chicago: The Municipal Code of Chicago (MCC) states in pertinent part that an Approved Agency is a Nationally Recognized Testing Laboratory (NRTL) acting within its recognized scope and/or a certification body accredited by the American National Standards Institute (ANSI) acting within its accredited scope. Construction materials and test procedures shall conform to the applicable standards listed in the MCC. Sufficient technical data shall be submitted to the building official to substantiate the proposed use of any product, material, service, design, assembly and/or method of construction not specifically provided for in the MCC. This technical data shall consist of research reports from approved sources (i.e., MCC defined Approved Agencies).
- 1.5 Approved by New York City: The <u>NYC Building Code 2022</u> (NYCBC) states in pertinent part that <u>an approved agency shall be deemed</u><sup>36</sup> an approved testing agency via <u>ISO/IEC 17025 accreditation</u>, an approved inspection agency via <u>ISO/IEC 17020</u> accreditation, and an approved product evaluation agency via <u>ISO/IEC 17065 accreditation</u>. Accrediting agencies, other than federal agencies, must be members of an internationally recognized cooperation of laboratory and inspection accreditation bodies subject to a mutual recognition agreement<sup>37</sup> (i.e., <u>ANAB</u>, <u>International Accreditation Forum</u> (IAF), etc.).

- 1.6 Approved by Florida: Statewide approval of products, methods, or systems of construction shall be approved, without further evaluation, by 1) A certification mark or listing of an approved certification agency, 2) A test report from an approved testing laboratory, 3) A product evaluation report based upon testing or comparative or rational analysis, or a combination thereof, from an approved product evaluation entity; 4) A product evaluation report based upon testing or comparative or rational analysis, or a combination thereof, developed and signed and sealed by a professional engineer or architect, licensed in Florida. For local product approval, products or systems of construction shall demonstrate compliance with the structural wind load requirements of the Florida Building Code (FBC) through one of the following methods; 1) A certification mark, listing, or label from a commission-approved certification agency indicating that the product complies with the code; 2) A test report from a commission-approved testing laboratory indicating that the product tested complies with the code; 3) A product-evaluation report based upon testing, comparative or rational analysis, or a combination thereof, from a commission-approved product evaluation entity which indicates that the product evaluated complies with the code: 4) A product-evaluation report or certification based upon testing or comparative or rational analysis, or a combination thereof, developed and signed and sealed by a Florida professional engineer or Florida registered architect, which indicates that the product complies with the code; 5) A statewide product approval issued by the Florida Building Commission. The Florida Department of Business and Professional Regulation (DBPR) website provides a listing of companies certified as a Product Evaluation Agency (i.e., EVLMiami 13692), a Product Certification Agency (i.e., CER10642), and as a Florida Registered Engineer (i.e., ANE13741).
- 1.7 **Approved by Miami-Dade County (i.e., Notice of Acceptance [NOA])**: A Florida statewide approval is an NOA. An NOA is a Florida local product approval. By Florida law, Miami-Dade County shall accept the statewide and local Florida Product Approval as provided for in Florida legislation <u>553.842</u> and <u>553.8425</u>.
- 1.8 Approved by New Jersey: Pursuant to Building Code 2018 of New Jersey in IBC Section 1707.1 General,<sup>38</sup> it states; "In the absence of approved rules or other approved standards, the building official shall accept duly authenticated reports from approved agencies in respect to the quality and manner of use of new materials or assemblies as provided for in the administrative provisions of the Uniform Construction Code (N.J.A.C. 5:23)".39 Furthermore N.J.A.C 5:23-3.7 states: Municipal approvals of alternative materials, equipment, or methods of construction. (a) Approvals: Alternative materials, equipment, or methods of construction shall be approved by the appropriate subcode official provided the proposed design is satisfactory and that the materials, equipment, or methods of construction are suitable for the intended use and are at least the equivalent in guality, strength, effectiveness, fire resistance, durability and safety of those conforming with the requirements of the regulations. 1. A field evaluation label and report or letter issued by a nationally recognized testing laboratory verifying that the specific material, equipment, or method of construction meets the identified standards or has been tested and found to be suitable for the intended use, shall be accepted by the appropriate subcode official as meeting the requirements of (a) above. 2. Reports of engineering findings issued by nationally recognized evaluation service programs, such as, but not limited to, the Building Officials and Code Administrators (BOCA), the International Conference of Building Officials (ICBO), the Southern Building Code Congress International (SBCCI), the International Code Council (ICC), and the National Evaluation Service, Inc., shall be accepted by the appropriate subcode official as meeting the requirements of (a) above. The New Jersey Department of Community Affairs has confirmed that technical evaluation reports, from any accredited entity listed by ANAB, meets the requirements of item 2 given that the listed entities are no longer in existence and/or do not provide "reports of engineering findings".

- 1.9 **Approved by the Code of Federal Regulations Manufactured Home Construction and Safety Standards**: Pursuant to Title 24, Subtitle B, Chapter XX, <u>Part 3282.14</u><sup>40</sup> and <u>Part 3280</u>,<sup>41</sup> the Department encourages innovation and the use of new technology in manufactured homes. The design and construction of a manufactured home shall conform with the provisions of Part 3282 and Part 3280 where key approval provisions in mandatory language follow: 1) "All construction methods shall be in conformance with accepted engineering practices"; 2) "The strength and rigidity of the component parts and/or the integrated structure shall be determined by engineering analysis or by suitable load tests to simulate the actual loads and conditions of application that occur."; and 3) "The design stresses of all materials shall conform to accepted engineering practice."
- 1.10 **Approval by US, Local, and State Jurisdictions in General**: In all other local and state jurisdictions, the adopted building code legislation states in pertinent part that:
  - 1.10.1 For <u>new materials</u> that are not specifically provided for in this code, the <u>design strengths and permissible</u> <u>stresses</u> shall be established by tests.<sup>42</sup>
  - 1.10.2 For <u>innovative alternative products</u>, <u>materials</u>, <u>designs</u>, <u>services and/or methods of construction</u>, in the absence of approved rules or other approved standards…the building official shall accept duly authenticated reports (i.e., listing and/or research report) from <u>approved agencies</u> with respect to the quality and manner of use of <u>new materials or assemblies</u>.<sup>43</sup> A building official <u>approved agency</u> is deemed to be approved via certification from an <u>accreditation body</u> that is listed by the <u>International Accreditation</u> <u>Forum</u><sup>44</sup> or equivalent.
  - 1.10.3 The <u>design strengths and permissible stresses</u> of any structural material...shall conform to the specifications and methods of design of accepted engineering practice performed by an <u>approved</u> <u>source</u>.<sup>45</sup> An <u>approved source</u> is defined as a PE subject to professional engineering laws, where a research and/or a technical evaluation report certified by a PE, shall be approved.
- 1.11 **Approval by International Jurisdictions**: The <u>USMCA</u> and <u>GATT</u> agreements provide for approval of innovative materials, products, designs, services, assemblies and/or methods of construction through the <u>Technical Barriers to Trade</u> agreements and the <u>International Accreditation Forum (IAF) Multilateral</u> <u>Recognition Arrangement (MLA)</u>, where these agreements:
  - 1.11.1 Permit participation of <u>conformity assessment bodies</u> located in the territories of other Members (defined as GATT Countries) under conditions no less favourable than those accorded to bodies located within their territory or the territory of any other country,
  - 1.11.2 State that <u>conformity assessment procedures</u> (i.e., ISO/IEC 17020, 17025, 17065, etc.) are prepared, adopted, and applied so as to grant access for suppliers of like products originating in the territories of other Members under conditions no less favourable than those accorded to suppliers of like products of national origin or originating in any other country, in a comparable situation.
  - 1.11.3 State that conformity assessment procedures are not prepared, adopted, or applied with a view to or with the effect of creating unnecessary obstacles to international trade. This means that conformity assessment procedures <u>shall not be more strict</u> or be applied more strictly than is necessary to give the importing Member adequate confidence that products conform to the applicable technical regulations or standards.

1.11.4 **Approved**: The <u>purpose of the IAF MLA</u> is to ensure mutual recognition of accredited certification and validation/verification statements between signatories to the MLA, and subsequently acceptance of accredited certification and validation/verification statements in many markets based on one accreditation for the timely approval of innovative materials, products, designs, services, assemblies and/or methods of construction.
