## 1 Innovative Products Evaluated<sup>1</sup>

  - 1.1.3 SPAX T-Star Pancake Head PowerLags Fastener
  - 1.1.4 SPAX T-Star plus Cylindric Head PowerLags Fastener

# 2 Product Description and Materials




Figure 1. SPAX Hex Washer Head PowerLags Fastener




Figure 2. SPAX T-Star Washer Head PowerLags Fastener




Figure 3. SPAX T-Star Pancake Head PowerLags Fastener




Figure 4. SPAX T-Star plus Cylindric Head PowerLags Fastener

- 2.1 The innovative products evaluated in this report are shown in Figure 1, Figure 2, Figure 3 and Figure 4.
- 2.2 General
  - 2.2.1 SPAX PowerLags Series Structural Wood Fasteners described in this report are threaded fasteners manufactured using a standard cold forming process and subsequently heat-treated and coated.
  - 2.2.2 The fasteners are available with a variety of coatings, including proprietary coating systems designated as zinc, yellow zinc, HCR™, HCR-X™ and WIROX®.
  - 2.2.3 SPAX PowerLags Series Structural Wood Fasteners are available in five different diameters and four different head types. They have lengths ranging from 1 to 24 inches (25 to 610 mm), inclusive of the threaded portion. The four head types are as follows:
    - 2.2.3.1 Hex Washer Head design (Figure 1).
    - 2.2.3.2 T-Star Washer Head design with 6-Lobe recess drive system (Figure 2).
    - 2.2.3.3 T-Star Pancake Head design with 6-Lobe recess drive system (Figure 3).
    - 2.2.3.4 T-Star plus Cylindric Head design with 6-Lobe recess drive system containing a post (Figure 4).





2.2.4 For fastener diameters, lengths, and head types, see **Table 1** for #14, **Table 2** for  $^{1}/_{4}$ ", **Table 3** for  $^{5}/_{16}$ ", **Table 4** for  $^{3}/_{8}$ " and **Table 5** for  $^{1}/_{2}$ " series. All fasteners described in this report are manufactured with cold rolled threads and a gimlet point.

#### 2.3 Fastener Material

2.3.1 SPAX PowerLags Series Structural Wood Fasteners are made of hardened carbon steel grade 10B18, 1022 or 10B21 wire conforming to ASTM A510 or grade 17MnB3 or 19MnB4 wire conforming to DIN 1654.

#### 2.4 Corrosion Resistance

## 2.4.1 Interior Wood Applications:

2.4.1.1 The SPAX PowerLags Series Structural Wood Fasteners with the proprietary zinc, yellow zinc and WIROX coatings are equivalent to the protection provided by code-approved hot-dipped galvanized coatings meeting ASTM A153, Class D (<u>IBC Section 2304.10.6</u><sup>2</sup> and <u>IRC Section R317.3</u>) when recognized for use in untreated wood and above ground contact pressure treated wood with waterborne alkaline copper quaternary, Type D (ACQ-D), to a maximum retention level of 0.40 pcf (6.4 kg/m³), interior, dry/damp general construction applications (i.e., Above Ground AWPA UC1-UC2 ACQ-D).

## 2.4.2 Exterior Wood Applications:

2.4.2.1 The SPAX PowerLags Series Structural Wood Fasteners with the proprietary HCR and HCR-X coatings are equivalent to the protection provided by code-approved hot-dipped galvanized coatings meeting ASTM A153, Class D (IBC Section 2304.10.6³ and IRC Section R317.3) when recognized for use in untreated wood and ground contact pressure treated wood with waterborne alkaline copper quaternary, Type D (ACQ-D), to a minimum retention level of 0.40 pcf (6.4 kg/m³), exterior, freshwater, general construction applications (i.e., Above Ground AWPA UC1-UC4A ACQ-D).

#### 2.4.3 Fire-Retardant Treated (FRT) Wood Applications:

2.4.3.1 SPAX PowerLags Series Structural Wood Fasteners proprietary coating systems designated as zinc, yellow zinc, HCR, HCR-X and WIROX are recognized for use in FRT lumber, provided the conditions set forth by the FRT lumber manufacturer are met, including appropriate strength reductions.

### 2.5 Wood Material

- 2.5.1 Wood main and side members must be solid-sawn lumber or boards having an assigned specific gravity as given in the respective tables of this report. Assigned specific gravity must be determined in accordance with NDS Table 12.3.3A.
- 2.6 The SPAX PowerLags Series Structural Wood Fasteners evaluated in this report are set forth in Table 1, Table2, Table 3, Table 4 and Table 5.

- 2.7 As needed, review material properties for design in **Section 6** and to regulatory evaluation in **Section 8**.





### 3 Definitions

- 3.1 New Materials<sup>4</sup> are defined as building materials, equipment, appliances, systems, or methods of construction not provided for by prescriptive and/or legislatively adopted regulations, known as alternative materials.<sup>5</sup> The design strengths and permissible stresses shall be established by tests<sup>6</sup> and/or engineering analysis.<sup>7</sup>
- 3.2 <u>Duly Authenticated Reports</u><sup>8</sup> and <u>Research Reports</u><sup>9</sup> are test reports and related engineering evaluations, which are written by an approved agency<sup>10</sup> and/or an approved source.<sup>11</sup>
  - 3.2.1 These reports contain intellectual property and/or trade secrets, which are protected by the <u>Defend Trade Secrets Act</u> (DTSA). 12
- 3.3 An <u>approved agency</u> is "approved" when it is <u>ANAB ISO/IEC 17065 accredited</u>. DrJ Engineering, LLC (DrJ) is listed in the ANAB directory.
- 3.4 An <u>approved source</u> is "approved" when a professional engineer (i.e., <u>Registered Design Professional</u>) is properly licensed to transact engineering commerce. The regulatory authority governing approved sources is the state legislature via its professional engineering regulations.<sup>13</sup>
- 3.5 Testing and/or inspections conducted for this <u>Duly Authenticated Report</u> were performed by an <u>ISO/IEC 17025</u> accredited testing laboratory, an <u>ISO/IEC 17020</u> accredited inspection body, and/or a licensed <u>Registered</u> Design Professional (RDP).
  - 3.5.1 The Center for Building Innovation (CBI) is ANAB14 ISO/IEC 17025 and ISO/IEC 17020 accredited.
- 3.6 The regulatory authority shall <u>enforce</u><sup>15</sup> the specific provisions of each legislatively adopted regulation. If there is a non-conformance, the specific regulatory section and language of the non-conformance shall be provided in <u>writing</u><sup>16</sup> stating the nonconformance and the path to its cure.
- 3.7 The regulatory authority shall accept <u>Duly Authenticated Reports</u> from an <u>approved agency</u> and/or an <u>approved</u> source with respect to the quality and manner of use of new materials or assemblies as provided for in regulations regarding the use of alternative materials, designs, or methods of construction.<sup>17</sup>
- 3.8 ANAB is an <u>International Accreditation Forum</u> (IAF) <u>Multilateral Recognition Arrangement</u> (MLA) signatory where recognition of certificates, validation, and verification statements issued by conformity assessment bodies accredited by all other signatories of the IAF MLA with the appropriate scope, shall be approved.<sup>18</sup> Therefore, all ANAB ISO/IEC 17065 <u>Duly Authenticated Reports</u> are approval equivalent.<sup>19</sup>
- 3.9 Approval equity is a fundamental commercial and legal principle.<sup>20</sup>

- 7.1 All construction methods shall conform to accepted engineering practices to ensure durable, livable, and safe construction and shall demonstrate acceptable workmanship reflecting journeyman quality of work of the various trades.<sup>27</sup>
- 7.2 The strength and rigidity of the component parts and/or the integrated structure shall be determined by engineering analysis or by suitable load tests to simulate the actual loads and conditions of application that occur.<sup>28</sup>





## 8 Regulatory Evaluation and Accepted Engineering Practice

- 8.1 SPAX PowerLags Series Structural Wood Fasteners comply with the following legislatively adopted regulations and/or accepted engineering practice for the following reasons:
  - 8.1.1 SPAX PowerLags Series Structural Wood Fasteners were tested and evaluated to determine their structural resistance properties, which are used to develop reference design values for Allowable Stress Design (ASD). The following properties were evaluated:
    - 8.1.1.1 Bending yield in accordance with ASTM F1575
    - 8.1.1.2 Tensile strength in accordance with ASTM F606 and AISI S904
    - 8.1.1.3 Shear strength in accordance with ASTM F1575 and AISI S904
    - 8.1.1.4 Head pull-through in accordance with ASTM D1037 and ASTM D1761
    - 8.1.1.5 Withdrawal strength in accordance with ASTM D1761
    - 8.1.1.6 Lateral resistance in accordance with ASTM D1761 and NDS
    - 8.1.1.7 Corrosion resistance in accordance with ASTM B117 and ASTM G85
  - 8.1.2 The use of SPAX PowerLags Series Structural Wood Fasteners in locations exposed to saltwater or saltwater spray is outside the scope of this report.
  - 8.1.3 For connection design values for truss/rafter/joist to walls, stud to plate, and plate to rim board connections see Report Number 1910-02.
- 8.2 Any building code, regulation, and/or accepted engineering evaluations (i.e., research reports, <u>Duly Authenticated Reports</u>, etc.) that are conducted for this Listing were performed by DrJ Engineering, LLC (DrJ), an <u>ISO/IEC 17065 accredited certification body</u> and a professional engineering company operated by <u>RDP/approved sources</u>. DrJ is qualified<sup>29</sup> to practice product and regulatory compliance services within its scope of accreditation and engineering expertise, respectively.
- 8.3 Engineering evaluations are conducted with DrJ's ANAB <u>accredited ICS code scope</u> of expertise, which are also its areas of professional engineering competence.
- 8.4 Any regulation specific issues not addressed in this section are outside the scope of this report.

#### 9 Installation

- 9.1 Installation shall comply with the approved construction documents, the manufacturer installation instructions, this report and the applicable building code.
- 9.2 In the event of a conflict between the manufacturer installation instructions and this report, the more restrictive shall govern.
- 9.3 SPAX PowerLags Series Structural Wood Fasteners shall be installed using the driver bits specified in **Table 1**, **Table 2**, **Table 3**, **Table 4** and **Table 5**, as applicable.
- 9.4 Fasteners shall not be struck with a hammer during installation.
- 9.5 Lead Hole Requirements
  - 9.5.1 Lead holes are not required for #14, 1/4" and 5/16" SPAX PowerLags Series Structural Wood Fasteners.
  - 9.5.2 Lead holes of 0.172" (4.37 mm) diameter are required for <sup>3</sup>/<sub>8</sub>" SPAX PowerLags Series Structural Wood Fasteners.
  - 9.5.3 Lead holes of 0.203" (5.16 mm) diameter are required for ½" SPAX PowerLags Series Structural Wood Fasteners.
- 9.6 The fastener head must be installed flush to the surface of the wood side member being connected. The fastener must not be overdriven.
- 9.7 Minimum main member penetration is 11/2" unless otherwise stated in this report.





9.8 Minimum requirements for fastener spacing, edge distance, and end distance shall be in accordance with **Table 13**.

- 10.1 Testing has been performed under the supervision of a professional engineer and/or under the requirements of ISO/IEC 17025 as follows:
  - 10.1.1 Bending yield testing in accordance with ASTM F1575
  - 10.1.2 Tensile strength testing in accordance with AISI S904
  - 10.1.3 Shear strength testing in accordance with AISI S904
  - 10.1.4 Head pull-through testing in accordance with ASTM D1761
  - 10.1.5 Withdrawal testing in accordance with ASTM D1761
  - 10.1.6 Lateral connection testing in accordance with ASTM D1761
  - 10.1.7 Corrosion resistance testing in accordance with ASTM B117 and ASTM G85
- 10.2 Information contained herein may include the result of testing and/or data analysis by sources that are approved agencies, approved sources, and/or RDPs. Accuracy of external test data and resulting analysis is relied upon.
- 10.3 Where pertinent, testing and/or engineering analysis are based upon provisions that have been codified into law through state or local adoption of regulations and standards. The developers of these regulations and standards are responsible for the reliability of published content. DrJ's engineering practice may use a regulation-adopted provision as the control. A regulation-endorsed control versus a simulation of the conditions of application to occur establishes a new material as <a href="mailto:being equivalent">being equivalent</a> to the regulatory provision in terms of quality, <a href="mailto:strength">strength</a>, effectiveness, <a href="mailto:fire resistance">fire resistance</a>, durability, and safety.

These are presumed to be minimum properties and relied upon to be accurate. The reliability of DrJ's engineering practice, as contained in this <u>Duly</u> Authenticated Report, may be dependent upon published design properties by others.
- 10.5 Testing and engineering analysis: The strength, rigidity, and/or general performance of component parts and/or the integrated structure are determined by suitable tests that simulate the actual conditions of application that occur and/or by accepted engineering practice and experience.<sup>30</sup>
- 10.6 Where additional condition of use and/or regulatory compliance information is required, please search for SPAX PowerLags Series Structural Wood Fasteners on the DrJ Certification website.

### 11 Findings

- 11.1 As outlined in **Section 6**, SPAX PowerLags Series Structural Wood Fasteners have performance characteristics that were tested and/or meet applicable regulations and are suitable for use pursuant to their specified purpose.
- 11.2 When used and installed in accordance with this <u>Duly Authenticated Report</u> and the manufacturer installation instructions, SPAX PowerLags Series Structural Wood Fasteners shall be approved for the following applications:
  - 11.2.1 Provide resistance to head pull-through loads as shown in **Table 6**.
  - 11.2.2 Provide resistance to reference withdrawal loads as shown in **Table 7**.
- 11.3 Unless exempt by state statute, when SPAX PowerLags Series Structural Wood Fasteners are to be used as a structural and/or building envelope component in the design of a specific building, the design shall be performed by an RDP.
- 11.4 Any application specific issues not addressed herein can be engineered by an RDP. Assistance with engineering is available from Altenloh, Brinck & Company U.S., Inc.
- 11.5 IBC Section 104.11 (IRC Section R104.11 and IFC Section 104.10<sup>31</sup> are similar) in pertinent part states:
  - **104.11 Alternative materials, design and methods of construction and equipment.** The provisions of this code are not intended to prevent the installation of any material or to prohibit any design or method of construction not specifically prescribed by this code. Where the alternative material, design or method of construction is not approved, the building official shall respond in writing, stating the reasons the alternative was not approved.
- 11.6 Approved: 32 Building regulations require that the building official shall accept Duly Authenticated Reports. 33
  - 11.6.1 An approved agency is "approved" when it is ANAB ISO/IEC 17065 accredited.
  - 11.6.2 An approved source is "approved" when an RDP is properly licensed to transact engineering commerce.
  - 11.6.3 Federal law, <u>Title 18 US Code Section 242</u>, requires that where the alternative product, material, service, design, assembly, and/or method of construction is not approved, the building official shall respond in writing, stating the reasons why the alternative was not approved. Denial without written reason deprives a protected right to free and fair competition in the marketplace.
- 11.7 DrJ is a licensed engineering company, employs licensed <u>RDP</u>s and is an <u>ANAB-Accredited Product</u> Certification Body Accreditation #1131.
- 11.8 Through the <u>IAF Multilateral Agreements</u> (MLA), this <u>Duly Authenticated Report</u> can be used to obtain product approval in any <u>jurisdiction</u> or <u>country</u> because all ANAB ISO/IEC 17065 <u>Duly Authenticated Reports</u> are equivalent.<sup>34</sup>





- 12.1 Material properties shall not fall outside the boundaries defined in Section 6.
- 12.2 As defined in **Section 6**, where material and/or engineering mechanics properties are created for load resisting design purposes, the resistance to the applied load shall not exceed the ability of the defined properties to resist those loads using the principles of accepted engineering practice.
- 12.3 Wood main and side members must have a moisture content of less than or equal to nineteen percent (19%). Where fasteners are installed in a wet service condition, the appropriate reduction factors shall be applied per NDS Table 11.3.1.
- 12.4 The use of SPAX PowerLags Series Structural Wood Fasteners in locations exposed to saltwater or saltwater spray are outside the scope of this report.
- 12.5 In cases where fastener metal capacity (instead of the wood member) controls the connection design, the allowable connection strength shall not be multiplied by the adjustment factors specified in NDS.
- 12.6 When required by adopted legislation and enforced by the <u>building official</u>, also known as the authority having jurisdiction (AHJ) in which the project is to be constructed:
  - 12.6.1 Any calculations incorporated into the construction documents shall conform to accepted engineering practice and, when prepared by an <u>approved source</u>, shall be approved when signed and sealed.
  - 12.6.2 This report and the installation instructions shall be submitted at the time of permit application.
  - 12.6.3 These innovative products have an internal quality control program and a third-party quality assurance program.
  - 12.6.4 At a minimum, these innovative products shall be installed per **Section 9** of this report.
  - 12.6.5 The review of this report by the AHJ shall comply with IBC Section 104 and IBC Section 105.4.
  - 12.6.6 These innovative products have an internal quality control program and a third party quality assurance program in accordance with <u>IBC Section 104.4</u>, <u>IBC Section 110.4</u>, <u>IBC Section 1703</u>, <u>IRC Section R104.4</u>, and IRC Section R109.2.
  - 12.6.7 The application of these innovative products in the context of this report is dependent upon the accuracy of the construction documents, implementation of installation instructions, inspection as required by <u>IBC</u> Section 110.3, IRC Section R109.2, and any other regulatory requirements that may apply.
- 12.7 The approval of this report by the AHJ shall comply with <u>IBC Section 1707.1</u>, where legislation states in part, "the <u>building official</u> shall accept duly authenticated reports from <u>approved agencies</u> in respect to the quality and manner of <u>use</u> of new material or assemblies as provided for in <u>Section 104.11</u>," all of <u>IBC Section 104</u>, and IBC Section 105.4.
- 12.8 <u>Design loads</u> shall be determined in accordance with the regulations adopted by the <u>jurisdiction</u> in which the project is to be constructed and/or by the building designer (i.e., owner or RDP).
- 12.9 The actual design, suitability, and use of this report for any particular building, is the responsibility of the <u>owner</u> or the authorized agent of the owner.

  - 1.1.2 Promote competition so all businesses have the opportunity to compete on price and quality in an open market on a level playing field unhampered by anticompetitive constraints, and
  - 1.1.3 Benefit consumers through lower prices, better quality, and greater choice.
- 1.2 **Adopted Legislation**: The following local, state, and federal regulations affirmatively authorize these innovative products to be approved by AHJs, delegates of building departments, and/or delegates of an agency of the federal government:
  - 1.2.1 Interstate commerce is governed by the <u>Federal Department of Justice</u> to encourage the use of innovative products, materials, designs, services, assemblies, and/or methods of construction. The goal is to "protect economic freedom and opportunity by promoting free and fair competition in the marketplace."
  - 1.2.2 <u>Title 18 US Code Section 242</u> affirms and regulates the right of individuals and businesses to freely and fairly have new products, materials, designs, services, assemblies, and/or methods of construction approved for use in commerce. Disapproval of alternatives shall be based upon non-conformance with respect to specific provisions of adopted legislation and shall be provided in writing <u>stating the reasons why the alternative was not approved</u>, with reference to the specific legislation violated.
  - 1.2.3 The <u>federal government</u> and each state have a <u>public records act</u>. In addition, each state also has legislation that mimics the federal <u>Defend Trade Secrets Act 2016</u> (DTSA),<sup>35</sup> where providing test reports, engineering analysis and/or other related IP/TS is subject to <u>prison of not more than ten years</u><sup>36</sup> and/or a \$5,000,000 fine or 3 times the value of<sup>37</sup> the Intellectual Property (IP) and Trade Secrets (TS).
    - 1.2.3.1 Compliance with public records and trade secret legislation requires approval through the use of <a href="Listings">Listings</a>, certified reports, Technical Evaluation Reports, Duly Authenticated Reports, and/or research reports prepared by approved agencies and/or approved sources.
  - 1.2.4 For <u>new materials</u><sup>38</sup> that are not specifically provided for in any regulation, the <u>design strengths and</u> <u>permissible stresses</u> shall be established by <u>tests</u>, where <u>suitable load tests simulate the actual loads and</u> conditions of application that occur.
  - 1.2.5 The <u>design strengths and permissible stresses</u> of any structural material shall <u>conform</u> to the specifications and methods of design using accepted engineering practice.<sup>39</sup>
  - 1.2.6 The commerce of <u>approved sources</u> (i.e., registered PEs) is regulated by <u>professional engineering</u> <u>legislation</u>. Professional engineering <u>commerce shall always be approved</u> by AHJs, except where there is evidence provided in writing, that specific legislation have been violated by an individual registered PE.
  - 1.2.7 The AHJ shall accept <u>Duly Authenticated Reports</u> from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in <u>IBC Section 104.11</u>.<sup>40</sup>





- 1.3 Approved<sup>41</sup> by Los Angeles: The Los Angeles Municipal Code (LAMC) states in pertinent part that the provisions of LAMC are not intended to prevent the use of any material, device, or method of construction not specifically prescribed by LAMC. The Department shall use Part III, Recognized Standards in addition to Part II, Uniform Building Code Standards of Division 35, Article 1, Chapter IX of the LAMC in evaluation of products for approval where such standard exists for the product or the material and may use other approved standards that apply. Whenever tests or certificates of any material or fabricated assembly are required by Chapter IX of the LAMC, such tests or certification shall be made by a testing agency approved by the Superintendent of Building to conduct such tests or provide such certifications. The testing agency shall publish the scope and limitation(s) of the listed material or fabricated assembly. <sup>42</sup> The Superintendent of Building Approved Testing Agency Roster is provided by the Los Angeles Department of Building and Safety (LADBS). The Center for Building Innovation (CBI) Certificate of Approval License is TA24945. Tests and certifications found in a DrJ Listing are LAMC approved. In addition, the Superintendent of Building shall accept Duly Authenticated Reports from approved agencies in respect to the quality and manner of use of new materials or assemblies as provided for in the California Building Code (CBC) Section 1707.1.<sup>43</sup>
- 1.4 Approved by Chicago: The Municipal Code of Chicago (MCC) states in pertinent part that an Approved Agency is a Nationally Recognized Testing Laboratory (NRTL) acting within its recognized scope and/or a certification body accredited by the American National Standards Institute (ANSI) acting within its accredited scope. Construction materials and test procedures shall conform to the applicable standards listed in the MCC. Sufficient technical data shall be submitted to the building official to substantiate the proposed use of any product, material, service, design, assembly, and/or method of construction not specifically provided for in the MCC. This technical data shall consist of research reports from approved sources (i.e., MCC defined Approved Agencies).
- 1.5 **Approved by New York City**: The 2022 NYC Building Code (NYCBC) states in part that an <u>approved agency</u> shall be deemed<sup>44</sup> an approved testing agency via <u>ISO/IEC 17025 accreditation</u>, an approved inspection agency via <u>ISO/IEC 17020 accreditation</u>, and an approved product evaluation agency via <u>ISO/IEC 17065</u> <u>accreditation</u>. Accrediting agencies, other than federal agencies, must be members of an internationally recognized cooperation of laboratory and inspection accreditation bodies subject to a mutual recognition agreement<sup>45</sup> (i.e., ANAB, International Accreditation Forum [IAF], etc.).
- 1.6 **Approved by Florida**: <u>Statewide approval</u> of products, methods, or systems of construction shall be approved, without further evaluation by:
  - 1.6.1 A certification mark or listing of an approved certification agency,
  - 1.6.2 A test report from an approved testing laboratory,
  - 1.6.3 A product evaluation report based upon testing or comparative or rational analysis, or a combination thereof, from an approved product evaluation entity, or
  - 1.6.4 A product evaluation report based upon testing, comparative or rational analysis, or a combination thereof, developed, signed and sealed by a professional engineer or architect, licensed in Florida.
  - 1.6.5 For local product approval, products or systems of construction shall demonstrate compliance with the structural wind load requirements of the Florida Building Code (FBC) through one of the following methods:
    - 1.6.5.1 A certification mark, listing or label from a commission-approved certification agency indicating that the product complies with the code,
    - 1.6.5.2 A test report from a commission-approved testing laboratory indicating that the product tested complies with the code,
    - 1.6.5.3 A product-evaluation report based upon testing, comparative or rational analysis, or a combination thereof, from a commission-approved product evaluation entity which indicates that the product evaluated complies with the code,





- 1.6.5.4 A product-evaluation report or certification based upon testing or comparative or rational analysis, or a combination thereof, developed and signed and sealed by a Florida professional engineer or Florida registered architect, which indicates that the product complies with the code, or
- 1.6.5.5 A statewide product approval issued by the Florida Building Commission.
- 1.6.6 The <u>Florida Department of Business and Professional Regulation</u> (DBPR) website provides a listing of companies certified as a <u>Product Evaluation Agency</u> (i.e., EVLMiami 13692), a <u>Product Certification Agency</u> (i.e., CER10642), and as a <u>Florida Registered Engineer</u> (i.e., ANE13741).
- 1.7 **Approved by Miami-Dade County (i.e., Notice of Acceptance [NOA])**: A Florida statewide approval is an NOA. An NOA is a Florida local product approval. By Florida law, Miami-Dade County shall accept the statewide and local Florida Product Approval as provided for in Florida legislation 553.842 and 553.8425.
- 1.8 **Approved by New Jersey**: Pursuant to the 2018 Building Code of New Jersey in <u>IBC Section 1707.1</u>

  <u>General</u>, <sup>46</sup> it states: "In the absence of approved rules or other approved standards, the building official shall accept duly authenticated reports from <u>approved agencies</u> in respect to the quality and manner of use of new materials or assemblies as provided for in the administrative provisions of the Uniform Construction Code (<u>N.J.A.C. 5:23</u>)". <sup>47</sup> Furthermore N.J.A.C 5:23-3.7 states: "Municipal approvals of alternative materials, equipment, or methods of construction."
  - 1.8.1 **Approvals**: Alternative materials, equipment, or methods of construction shall be approved by the appropriate subcode official provided the proposed design is satisfactory and that the materials, equipment, or methods of construction are suitable for the intended use and are at least the equivalent in quality, strength, effectiveness, fire resistance, durability, and safety of those conforming with the requirements of the regulations.
    - 1.8.1.1 A field evaluation label and report or letter issued by a nationally recognized testing laboratory verifying that the specific material, equipment, or method of construction meets the identified standards or has been tested and found to be suitable for the intended use, shall be accepted by the appropriate subcode official as meeting the requirements of the above.
    - 1.8.1.2 Reports of engineering findings issued by nationally recognized evaluation service programs such as but not limited to, the Building Officials and Code Administrators (BOCA), the International Conference of Building Officials (ICBO), the Southern Building Code Congress International (SBCCI), the International Code Council (ICC), and the National Evaluation Service, Inc., shall be accepted by the appropriate subcode official as meeting the requirements of the above.
  - 1.8.2 The New Jersey Department of Community Affairs has confirmed that technical evaluation reports, from any accredited entity listed by ANAB, meets the requirements of item the previous paragraph, given that the listed entities are no longer in existence and/or do not provide "reports of engineering findings."
- 1.9 Approved by the Code of Federal Regulations Manufactured Home Construction and Safety Standards: Pursuant to Title 24, Subtitle B, Chapter XX, Part 3282.14 and Part 3280, the Department encourages innovation and the use of new technology in manufactured homes. The design and construction of a manufactured home shall conform to the provisions of Part 3282 and Part 3280 where key approval provisions in mandatory language follow:
  - 1.9.1 "All construction methods shall be in conformance with accepted engineering practices."
  - 1.9.2 "The strength and rigidity of the component parts and/or the integrated structure shall be determined by engineering analysis or by suitable load tests to simulate the actual loads and conditions of application that occur."
  - 1.9.3 "The design stresses of all materials shall conform to accepted engineering practice."





- 1.10 **Approval by US, Local and State Jurisdictions in General**: In all other local and state jurisdictions, the adopted building code legislation states in pertinent part that:
  - 1.10.1 For <u>new materials</u> that are not specifically provided for in this code, the <u>design strengths and permissible</u> <u>stresses</u> shall be established by tests.<sup>50</sup>
  - 1.10.2 For innovative <u>alternatives</u> and/or methods of construction, the building official shall accept <u>Duly</u>
    <u>Authenticated Reports</u> from <u>approved agencies</u> with respect to the quality and manner of use of <u>new</u> materials or assemblies.<sup>51</sup>
    - 1.10.2.1 An <u>approved agency</u> is "approved" when it is <u>ANAB ISO/IEC 17065 accredited</u>. DrJ Engineering, LLC (DrJ) is in the ANAB directory.
    - 1.10.2.2 An <u>approved source</u> is "approved" when an <u>RDP</u> is properly licensed to transact engineering commerce. The regulatory authority governing approved sources is the <u>state legislature</u> via its professional engineering regulations.<sup>52</sup>
  - 1.10.3 The <u>design strengths and permissible stresses</u> of any structural material...shall conform to the specifications and methods of design of accepted engineering practice performed by an <u>approved</u> source.<sup>53</sup>
- 1.11 **Approval by International Jurisdictions**: The <u>USMCA</u> and <u>GATT</u> agreements provide for approval of innovative materials, designs, services, and/or methods of construction through the <u>Agreement on Technical Barriers to Trade</u> and the <u>IAF Multilateral Recognition Arrangement</u> (MLA), where these agreements:
  - 1.11.1 State that <u>conformity assessment procedures</u> (i.e., ISO/IEC 17020, 17025, 17065, etc.) are prepared, adopted, and applied so as to grant access for suppliers of like products originating in the territories of other Members under conditions no less favourable than those accorded to suppliers of like products of national origin or originating in any other country, in a comparable situation.
  - 1.11.2 **Approved**: The <u>purpose of the MLA</u> is to ensure mutual recognition of accredited certification and validation/verification statements between signatories to the MLA and subsequently, acceptance of accredited certification and validation/verification statements in many markets based on one accreditation for the timely approval of innovative materials, designs, services, and/or methods of construction.
  - 1.11.3 ANAB is an <u>IAF-MLA</u> signatory where recognition of certificates, validation, and verification statements issued by conformity assessment bodies accredited by all other signatories of the IAF MLA, with the appropriate scope, shall be approved.<sup>54</sup>
  - 1.11.4 Therefore, all ANAB ISO/IEC 17065 Duly Authenticated Reports are approval equivalent. 55
- 1.12 Approval equity is a fundamental commercial and legal principle. 56
